New Qualification Date for Juniors: Players born in 1991 or later.

**Playing Schedule**

Play will be on a group basis played in groups of eight, nine or ten on two tables, commencing at 9:00 am. Each Player will play a minimum of seven matches in the group followed by two knockout competitions (category 1 & category 2). Players finishing in the top half of a group will qualify for category 1 and the remainder for category 2. Where there are groups of nine, the top 4 will qualify for category 1.

At the first three tournaments in the series, category 1 will carry a weighting of 1.0 and category 2 will be .5. The weightings will be doubled at the final four tournaments (2.0 and 1.0) to encourage players who have been unable to attend the earlier events.

In the event of there being insufficient girls to form a minimum of one group of eight, the girls will play in mixed groups by ranking.

**General Notes**

The main advantage of this format is the time factor. All players will have played a minimum of seven matches in the group plus one knockout match, and the event should be completed by 6 p.m. The tournament is ideal for players of all ages.

This tournament is part of a series of seven junior table tennis tournaments . Although each tournament is separately run ( with individual trophies for the winner and runner up in each event ), points will be awarded for the boys and girls categories in each tournament as follows :

First three tournaments : 24 points for the winner of category 1, 16 points for the runner up, 8 points for losing semi-finalists, 4 points for losing quarter-finalists and 2 points for qualifying. Category 2 carries half the points of category 1.

Final three tournaments : The points will be doubled in both categories.

At the last tournament of the series, the prize fund of £1000 will be awarded per the prize fund list (separate sheet) with top cash prizes of £300 for overall winning boy and £200 for overall winning girl.

**TOURNAMENT REGULATIONS (to be retained)**

1. Every entrant must be affiliated to the ETTA Ltd. or another National Association in membership of the ITTF
2. ETTA Tournament Regulations including Regulation R (Racket Re-Rubbing) apply to this tournament.
3. Competitors will not be allowed to glue up within the confines of any of the buildings under any circumstances.
4. ITTF Regulations for International Competitions apply except those relating to matters covered by items marked (x) in the entry form.
5. Completion and submission of this entry form signifies agreement by the Entrant to the conditions of the Competition including variations from ITTF requirements.
6. All matches shall be the best of five games. Preliminary matches will be on a group basis. The final order in a group shall be determined as per ITTF regulation 3.7.5 for group competitions.
7. Competitors must wear rubber soled shoes and clothing which complies with ETTA Tournament Regulation 29. ITTF Clothing Regulation 3.2.2.9 will not apply (x).
8. Any member taking part in gambling, other than participation in any lottery or similar competition conducted by or with the permission of the organising committee, at a tournament approved by the ETTA shall be liable to immediate disqualification from the tournament and expulsion from the premises, either of which shall be reported to the ETTA
9. All competitors excluding foreign competitors may be required to umpire group matches. Qualified umpires shall be used for all finals.
10. Doping shall not take place either before or during play.
11. All Competitors must report to the Booking-In Control on arrival and should not leave the hall without first obtaining permission from the Referee. Players absent when called upon to play are liable to be scratched.
12. The referee's decision shall be final on a point of law and on any question arising not provided for in these regulations, or in any dispute as to the interpretation thereof. Decisions on points of fact by an umpire or assistant umpire appointed by the referee shall be final.
13. Players must have been born after 31st December, 1989.
14. All competitors must hold a valid ETTA Licence or have paid the appropriate Single Tournament Licence Fee with their entry form unless he/she is a member of another National Association affiliated to the ITTF and is not affiliated to the ETTA. Ltd.

**TOURNAMENT INFORMATION**

  2. **Entries** – If it is necessary to restrict entries this will be done on last received first out basis.
  3. **Draw** – The draw will take place on Wednesday 11th March, 2009 ( 7 – 30 p.m. ) at 1 Elm Avenue, Blackpool.
  4. **Admission** – There will be no charge for admission.
  5. **Playing Conditions** – Play throughout will be on 10 Butterfly tables, nets & posts, with Stiga 3 star balls(WHITE 40mm ). Individual court size 10m x 5m enclosed by surrounds. Scoring machines will be used for all matches. General white gas vapour lighting (x) 9m from a Grandsprung composite floor.
  6. **Doping** – Doping control tests may take place.
  7. **Practice** - There are no separate practice facilities. Competitors will be permitted to practise on tables not in use, at the discretion of the referee.
  8. **Changing** - The venue offers full changing and shower facilities.
  9. **Car Parking** – A car park is available at the venue (cars are parked at the owner's risk).
  10. **Refreshments** – Light refreshments and drinks will be available.
  11. **Prizes** – Trophies will be awarded to the winner and runner up in each category.
  12. **Notification** – Entrants will be notified of the time of their first match on each day.
- Accommodation** – Details of accommodation will be sent out with notification if requested.
